ORDER


Pursuant to Tennessee Code Annotated §36-3-603, if an Order of Protection is ordered by the Court and either the Petitioner or Respondent files a Complaint for Divorce, the Order of Protection shall remain in effect until the Court in which the divorce action lies modifies or dissolves the Order.

Therefore, to ensure proper notification is made to the legal authorities, Petitioner and Respondent, pursuant to Tennessee Code Annotated §36-3-609, the Domestic Courts for the Davidson County Circuit Court will require the following two filings on the Order of Protection case when a divorce is filed thereafter:

- 1) An Order containing both the Order of Protection Case Number and the Divorce Case Number should be submitted which extends the Order of Protection by operation of law until the divorce action modifies or dissolves the Order of Protection. (See APPENDIX A Order attached)

2) A separate Order should be submitted on the Order of Protection case when the divorce action is concluded or when the divorce action modifies or dissolves the Order of Protection. (See APPENDIX B Order attached)
