Category One Cases: Contracts, torts, personal injury, property damage, malpractice, wrongful death, employment discrimination, civil rights suits, tax disputes, special remedies and cases not otherwise specified.

Category Two Cases: Workers comp cases, appeals to Circuit from General Sessions, City Courts and other Courts or hearings; *Writs of Mandamus*; condemnation/inverse condemnation; *quo warranto* actions; and *Writs of Certiorari*.
