  - b) A copy of your birth certificate (it does not need to be a certified copy)
  - c) A copy of your official photo identification (government issued driver's license or passport; it does not need to be a "REAL ID" with the star on it)
  - d) A copy of your social security card

Note: The petition and documentation described in 3.b), 3.c), and 3.d) above will be placed under seal and will not be made available to the general public. If the name change is granted, the name change order will be a matter of public record (and not under seal).
