ABSTRACT OF JUDGMENT
✓ An <i>initial</i> filing fee is required.
AFFIDAVIT
✓ ADDITIONAL DOCKET TEXT: OF (affiant).
AMENDED COMPLAINT
✓ Use when a party is amending an original <i>Complaint/Petition</i> .
✓ ADDITIONAL DOCKET TEXT: OF (party filing) (document being amended).
✓ ADDITIONAL DOCKET TEXT: OF (plaintiff or defendant).
ANSWER
✓ Use when party is answering a <i>Complaint</i> or <i>Petition</i> filed against them.
<ul> <li>✓ ADDITIONAL DOCKET TEXT: OF (party filing) TO COMPLAINT/PETITION.</li> </ul>
ADDITIONAL DOORET TEXT. OF (party ming) TO COM EANNY ETHON.
ANSWER and COUNTER-COMPLAINT
✓ Use when a <b>deft</b> is <b>answering</b> and <b>countering</b> against the pltf.
✓ ADDITIONAL DOCKET TEXT: OF (party filing) AGAINST (party they are countering).
ANSWER and COUNTER PETITION
✓ Use when a <b>deft</b> is <b>answering</b> and <b>countering</b> (a <b>Petition</b> ) against the pltf.
✓ ADDITIONAL DOCKET TEXT: OF (party filing) AGAINST (party they are countering).
ANSWER and CROSS-COMPLAINT
✓ Use when a deft <b>answers</b> and files <b>cross-complaint</b> against another deft.
✓ ADDITIONAL DOCKET TEXT: OF (party answering) AGAINST (party "cross" against).
ANSWER and 3 <sup>RD</sup> PARTY COMPLAINTS
<ul> <li>Use when a deft <b>answers</b> and files a <i>Complaint</i> against a party <b>not</b> already listed in the original <i>Complaint</i>.</li> </ul>
ANSWER and 3 <sup>RD</sup> PARTY COMPLAINT TO A CATEGORY 1 CASE
ANSWER and 3 <sup>RD</sup> PARTY COMPLAINT TO A CATEGORY 2 CASE
ANSWER and 3 <sup>RD</sup> PARTY COMPLAINT TO A CATEGORY 3 CASE
ANSWER TO A COUNTER COMPLAINT
✓ Use when a party (usually pltf) is answering a Counter-Complaint.
✓ ADDITIONAL DOCKET TEXT: OF (party answering).
ANSWERS TO INTERROGATORIES

✓ ADDITIONAL DOCKET TEXT: OF (party answering Interrogatories).

APPEARANCE LETTER
<ul> <li>Use when an atty files a letter entering in his/her appearance for a party. If it is a pleading called a <i>Notice</i>, it will be a NAP.</li> </ul>
✓ ADDITIONAL DOCKET TEXT: (atty name) FOR (party s/he is representing).
ASSIGNMENT OF JUDGMENT
<ul> <li>Use when a judgment is transferred for collection.</li> </ul>
BILL OF PARTICULARS
✓ ADDITIONAL DOCKET TEXT: OF (party filing).
BRIEF
✓ ADDITIONAL DOCKET TEXT: (what type) OF (party filing).
CERTIFICATE OF GOOD FAITH
✓ Filed on medical malpractice cases.
✓ ADDITIONAL DOCKET TEXT: OF (plaintiff or defendant).
CERTIFICATE OF READINESS
✓ ADDITIONAL DOCKET TEXT: (which party's atty is submitting) and (length of trial time).
CHILD SUPPORT STATISTICAL INFO
✓ ADDITIONAL DOCKET TEXT: ENTER thru – NO COMMENT NEEDED.
CLAIMS OF EXEMPTION
COST BOND
✓ ADDITIONAL DOCKET TEXT: (atty name), SURETY FOR (party signing as surety).
<ul> <li>✓ Type SURETY to add attorney as surety on case.</li> </ul>
COUNTER COMPLAINT
✓ Use when a <b>defendant</b> is filing a <i>Complaint</i> against a plaintiff.
<ul> <li>✓ ADDITIONAL DOCKET TEXT: OF (party filing) AGAINST (party being filed against).</li> </ul>
ADDITIONAL DOORET TEXT. OF (party ming) FOR INOT (party being med againet).
CROSS COMPLAINT
✓ Use when a <b>defendant</b> is filing a <i>Complaint</i> against another named deft.
<ul> <li>✓ ADDITIONAL DOCKET TEXT: OF (party filing) AGAINST (party being filed against).</li> </ul>
DEFAULT JUDGMENT CERTIFICATE
✓ ADDITIONAL DOCKET TEXT: OF (party filing).
ADDITIONAL DOORET TEXT. OF (party ming).
DEPOSITION
✓ ADDITIONAL DOCKET TEXT: OF (person deposed) TAKEN (date of deposition.
ADDITIONAL DOORET TEXT. OF (person deposed) TAREN (date of deposition.

DETAILED ANNUAL ACCOUNTING

DISCOVERY EFFORT CERTIFICATE

✓ ADDITIONAL DOCKET TEXT: OF (party filing).

**EXHIBIT** 

INTERROGATORIES

- ✓ Use when one party files **questions** to be **answered** by another party.
- ✓ ADDITIONAL DOCKET TEXT: FROM (person filing) TO (person questions directed to).

INTERVENING COMPLAINTS

- ✓ Use when party **not** named in *Complaint* intervenes to **protect** their interest.
- ✓ ADDITIONAL DOCKET TEXT: *OF* (*party intervening*).

INTERVENING CIVIL COMPLAINT

**INTERVENING COMPLAINT CERTIORI & SUPERSEDAS** 

INTERVENING DOMESTIC COMPLAINT

LIEN LIS PENDENS

MARITAL DISSOLUTION AGREEMENT

- ✓ Used for **marital agreement** between plaintiff and defendant.
- ✓ ADDITIONAL DOCKET TEXT (if signed by both parties): OF BOTH PARTIES.
- ✓ ADDITIONAL DOCKET TEXT (if only signed by 1 party): OF (plaintiff or defendant).

**MEDICAL RECORDS FILED** 

- Records **subpoenaed** on a case will usually be accompanied by an *Affidavit* for fees charged for preparation.
- ✓ ADDITIONAL DOCKET TEXT: BY (medical office that filed records) FOR (party medical records are submitted on behalf of).

**MEDICAL RECORDS NO CHARGE** 

- ✓ Use when the medical office did **not** send a bill for copies.
- ✓ ADDITIONAL DOCKET TEXT: FROM (medical office that filed records) FOR (party medical records are submitted on behalf of).

### **MEMORANDUM**

- ✓ ADDITIONAL DOCKET TEXT: OF (who filed) and (what it is pertaining to).
- CAUTION! If titled "Memo in Opposition," it is probably a Response to a Motion .....VERY IMPORTANT that it be entered as such!

**MOTION TO CONTINUE\*** 

✓ Enter as Motion.

### **MOTION FOR DEFAULT\***

 $\checkmark$  Enter as *Motion*.

**MOTION IN LIMINE\*** 

- ✓ Enter as *Motion*.
- ✓ ADDITIONAL DOCKET TEXT: (IN LIMINE) RE: (provide a short description).

## **MOTION TO QUASH\***

✓ Use when quashing a **garnishment** or **execution**.

### **MOTION TO SET\***

✓ Enter as *Motion*.

## **MOTION FOR SLOW PAY\***

 $\checkmark$  Use when a party wants to pay installments on judgment.

# **MOTION FOR SUMMARY JUDGMENT\***

✓ Enter as *Motion*.

# **MOTION TO TERMINATE\***

✓ Use when a party wishes to stop support payments.

### NOTICE

✓ ADDITIONAL DOCKET TEXT: OF (who filed) and (what kind of Notice it is).

## NOTICE OF APPEARANCE

- ✓ ADDITIONAL DOCKET TEXT: (atty's name) FOR (who s/he is representing).
- ✓ Don't forget to type **ATTY**!

### **NOTICE OF HEARING**

✓ Use when an attorney **sets** or **continues** a *Motion* by pleading.

# NOTICE OF INSURANCE COVERAGE

✓ ADDITIONAL DOCKET TEXT: *OF (who filed)*.

### **NOTICE OF SUBMISSION**

Use when any ordered funds are paid into Court.
 NOTE: These funds must be mailed to Clerk's Office!

# **OBJECTION**

✓ Used when an atty **objects** to **contents** of *Order* filed by 1 of other parties in case.

# **OFFER OF JUDGMENT**

✓ ADDITIONAL DOCKET TEXT: OF (who is filing) FOR (amount of offer).

# PARENTING PLAN

✓ ADDITIONAL DOCKET TEXT: OF (who is filing).

# PETITION

✓ **Civil** cases: Petitions of Contempt.

## PETITION TO ENCROACH

- Used when party is trying to withdraw judgment money previously awarded to a minor who is now of age.
- ✓ Usually titled Petition to Encroach or for Settlement of Minor's Funds.

## PROOF OF CERTIFICATE OF SERVICE

✓ ADDITIONAL DOCKET TEXT: OF (who filed).

### **RECORDS FILED**

- ✓ Use when **non-medical records** are filed (i.e., *telephone, financial*, etc.).
- ✓ ADDITIONAL DOCKET TEXT: FROM (who records are from) FOR (who rcrds pertain to)

## REPLY

✓ ADDITIONAL DOCKET TEXT: OF (who filed) TO (describe what they are replying to).

## REPORT

## REQUEST

✓ ADDITIONAL DOCKET TEXT: OF (who filed) FOR (what request is for).

# RESPONSE

- ✓ Use when responding to anything except: (Motion or Complaint for Divorce use Answer code).
- ✓ ADDITIONAL DOCKET TEXT: OF (who filed) TO (what is being responded to).

# **RESPONSE TO MOTION**

✓ ADDITIONAL DOCKET TEXT: OF (who filed) TO (what is being responded to).

# SATISFACTION OF JUDGMENT (should be filed as a NOTICE)

✓ Use when party notifies us that a **judgment** in our Court has been satisfied.

# SEMINAR FOR DIVORCING PARENTS

- ✓ Use when verification received that a party has attended a seminar class for divorcing parents either by copy of their Certificate or a List.
- ✓ ADDITIONAL DOCKET TEXT: (name of party who attended) (date of attendance).

# STATEMENT

✓ ADDITIONAL DOCKET TEXT: *OF* (*who filed*) and (*describe the type of statement*).

# STATISTICAL DATA FORM

✓ Use for worker's compensation cases (should be placed UNDER SEAL).

# STATISTICAL INFORMATION

- ✓ Use for Statistical Sheet filed with new divorces or child support *Orders*.
- ✓ ADDITIONAL DOCKET TEXT: ENTER thru NO COMMENT NEEDED

STIPULATION

✓ ADDITIONAL DOCKET TEXT: OF (party/ies filing) RE: (what stipulation is).

**TEMPORARY INJUNCTION** 

✓ ADDITIONAL DOCKET TEXT: OF (party filing).

THIRD PARTY COMPLAINT

- ✓ Use when **deft** files *Complaint* against someone **not yet** a party to suit.
- ✓ ADDITIONAL DOCKET TEXT: OF (party filing) AGAINST (name of new defendant).
- ✓ A Summons to party(ies) being added is required.

THIRD PARTY COMPLAINT FOR A CATEGORY 1 CASE

THIRD PARTY COMPLAINT FOR A CATEGORY 2 CASE

THIRD PARTY COMPLAINT FOR DIVORCE W/MINOR CHILDREN

THIRD PARTY COMPLAINT FOR DIVORCE W/NO MINOR CHILDREN

THIRD PARTY COMPLAINT FOR DOMESTIC PETITION

TRANSCRIPT

✓ ADDITIONAL DOCKET TEXT: OF (party/ies filing) RE: (transcript details).

WAIVER OF

- ✓ Could be anything **but** usually regarding **service**.
  - ✓ ADDITIONAL DOCKET TEXT: (*item being waived*) OF (*party who is waiving it*).

WITNESS & EXHIBIT

- ✓ Use when attorney files **witness** and/or **exhibit list** for trial/hearing.
- ✓ ADDITIONAL DOCKET TEXT (if witness list only): WITNESS ONLY OF (party filing).
- ✓ ADDITIONAL DOCKET TEXT (if exhibit list only): EXHIBIT ONLY OF (party filing).

# \* Motion Entries

- All *Motions* **must** comply with the 2-week Rule!
- Motions for Summary Judgment must comply with the 37-day Rule.
