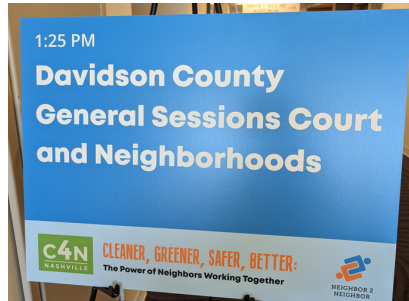
Southeast Egg Hunt

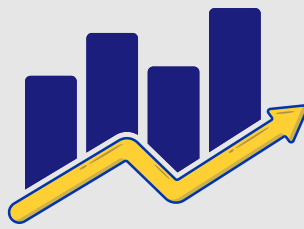


