FRIDAY, SEPTEMBER 27, 2024, MOTION DOCKET

The Staggered Motion Docket for this upcoming Friday, September 27th, is posted on the Circuit Court Clerk's website. We have a default docket and dockets at 9:00 a.m. and 9:30 a.m. Participation by Zoom is still an option for the default and 9:00 a.m. dockets. **The 9:30 a.m. docket is in-person.** We will hear cases until 11:00 a.m. at which time we will need to take a recess. We hope to conclude the docket by 11:00 a.m. If not, we will resume the docket at 1:30 p.m. for any remaining cases.

JUDICIAL CONFERENCE WEEK

Judicial Conference is October 14th - October 17th. The Court will maintain regular dockets during this week, including Special Master Ballinger's Order of Protection Docket. **NOTE: Irreconcilable Differences divorces heard on October 15th and October 16th will be only those with appearance waivers.**

FRIDAY, OCTOBER 25, 2024, MOTION DOCKET

There will be NO Motion Docket on Friday, October 25, 2024.

ORDERS FOR JUDGE KWELLER'S SIGNATURE

All proposed orders on matters heard by Judge Stanley A. Kweller must be submitted for entry no later than October 24, 2024.



Pre-Trial Conferences with Judge Williams are now required in all contested matters set for final hearing. Pre-Trial Conferences shall occur after the Judicial Settlement Conference and shall be conducted by videoconference. Pre-Trial Conferences shall be scheduled in conjunction with the Judicial Settlement Conference and Final Hearing, and the dates for all three shall be included in the Order to Set.

MOTIONS TO WAIVE HOMESTUDY, ORDER OF REFERENCE AND SIX-MONTH WAITING PERIOD

If an adoption case meets the statutory requirements for a waiver of the home study, order of reference and six-month waiting period, an order for the same may be filed without the necessity of a motion. Please note the order waiving must be entered BEFORE a Motion to Set will be granted.

ORDERS TO SET

Orders to Set a final hearing in all termination of parental rights and adoption cases must be filed a minimum of 11 days (*including holidays and weekends*) prior to the final hearing date.
