OUR FIRST 30 DAYS

We've officially completed our First 30 Days of this term! We started the month engaging in difficult and necessary conversations about how we can better serve families, our community and all of you. These conversations were productive and resulted in the following changes in our Court:

- We committed to maintain timely and consistent communications about the Fourth Circuit Court. We've accomplished this goal through our weekly newsletters. Thank you all for your kind words and feedback about this endeavor. We are excited to continue to make these weekly communications an ongoing part of our service.
- We implemented a Zoom option for motion hearings that do not require testimony.
- We implemented a no appearance docket for Irreconcilable Differences divorce hearings.
- We now hear uncontested and default adoption cases on the 2nd and 4th Monday of each month, and all Mondays are dedicated to contested Termination of Parental Rights and Adoption trials.
- We added a day and now hear Irreconcilable Differences and Default Divorce proceedings on Tuesday, Wednesday, and Thursday of each week.
- We implemented Pre-Trial Conferences for all contested cases to aid in trial preparation and to facilitate a more efficient trial practice.
- We implemented a monthly Status Conference Docket to track cases and assist attorneys and litigants in moving toward a timely adjudication of their case.

Your support and feedback allowed us to successfully implement all these changes.
