
# Cartwright to Become Traffic Bureau

Circuit Court Clerk Richard Rooker has announced the appointment of Bill Cartwright as chief clerk of the Traffic Violations Bureau, effective Jan. 1.

Cartwright, who is presently serving as supervisor of the bureau's warrant office, will succeed Ed Chauvin, who has announced his retirement as of Dec. 31.

Chauvin has been chief clerk of the department since November 1994, following nine years of service as busi-

"Ed has made a very large contribution to the efficiency level of the bureau over the past 13 years," said Rooker. "He deserves our gratitude

and best wishes for a happy retirement."

Cartwright, 31, joined the warrant office staff in 1992, bringing with him degrees from David Lipscomb University in business management and marketing. Effective application of those skills earned him the position of office supervisor in 1996.

"Bill's leadership qualities and technical knowledge, combined with a levelheaded approach to business management, made him the logical choice for the chief clerk's

## **Sidney Bennett Gets Domestic**

## Prosecutor Post

Attorney Sidney S. F. Bennett, a veteran family law practitioner, has assumed the position of special prosecutor in the county's domestic courts.

Bennett beat out some 30 other



applicants for the position, formerly held by Scott Rosenberg before he became a fulltime referee in Juvenile Court in August.

Like Rosenberg,

Bennett is a former aide to the district attorney general, whose office became guardian of the newly created domestic relations post last Spring when a state court of appeals ruled that private attorneys should not be permitted to prosecute criminal contempt charges growing out of civil cases in which they are involved.

That decision is currently under appeal in the state supreme court and, if overturned, could abolish the domestic court position.

Bennett, 41, maintains a private family law practice and is an approved Rule 31 mediator in the field of family mediation.

She graduated cum laude from Vanderbilt University College of

## New Workers' Comp Forms Adding \$1 to Clerical Fees

New federal guidelines for logging information in workers' compensation cases has increased the amount of paperwork for employers and court clerks while slightly increasing filing costs.

Circuit Court Clerk Richard Rooker said a "Statistical Data Form" now required under the federal Uniform Administrative Procedures Act will add \$1 to the standard filing fee of workers' comp settlements and to the accruing court costs in contested cases.

The extra fee goes into effect on Dec. 1.

The new two-page data forms, developed by the Department of Labor, became mandatory supplements this month to all

final orders in workers' comp litigation.

"The completed form shall be required to be filed in every workers' compensation case at the conclusion of the case and shall be filed with the clerk of the court (in which the case is pending) contemporaneously with the final order," according to the administrative procedures act. "An order of a court is not final until the statistical data form...is fully completed and filed with the clerk of the court."

Rooker explained that his office is required to forward a copy of the data form to the Department of Labor by the tenth of the month subsequent to the month in which it was filed.

The forms are available at the clerk's office.


He and his wife Tracy, a deputy in the circuit court clerk's office, are the parents of two daughters, Kelsey, 8, and Mikayla, 3.


