Circuit, Probate, General Sessions OnLine in July

'Working' Forms Coming to Web Site

A new service that will enable attorneys and others to complete civil legal forms simply by downloading them to their computers will be in operation on July 1.

Forms most frequently used in circuit, probate and general sessions courts will be accessible on the Circuit Court Clerk's web site in Word format, the most popular software among law firms.

Users simply need to select the form of choice and save it to their computer hard drive where it allows for data entry. Each form will automatically take the user through the required fields of entry, allowing information to be typed on-screen. A simple tab will take the user to the next field until the form has been completed.

Once completed, the form can be printed and submitted to clerks as official documents. They also can be retained for permanent record in the user's computer directory.

Circuit Court Clerk Richard Rooker pointed out that PDF-formatted forms would continue to be offered on the circuit web site, providing an option for those visiting the internet site. While those forms are not formatted for data entry, they can be downloaded for printing purposes.

All internet forms are letter-sized to comply with Supreme Court Rule 36 regarding paper size.

Satellite Office To Open July 1 In Ben West

Good news for downtown law firms.

Beginning July 1, civil court clerks will man a satellite office in the Ben West Building.

The office, which will be located at the east end of the building's main floor, will be open from 8 a.m. to 4 p.m. Monday-Friday.

Service will be limited to stamp filings for papers directed to circuit, chancery and general sessions civil division courts. Filing fees must be paid at the satellite office at the time of filing, but receipts will not be issued until the files have been processed at the respective main clerks' offices in the Metro Center.

Any filings needing immediate attention by the courts, as well as all probate documents, must be filed at the Metro Center offices.

"Because the vast majority of attorneys are located in the downtown area," said Circuit Court Clerk Richard Rooker, "the satellite office should save a lot of travel time and other inconveniences related to the temporary displacement of the court system."

Two Criminal, One Chancery

Three New Judgeships On Tap for September

The long-anticipated addition of three new state trial courts will become a reality in a matter of weeks.

The state legislature recently gave final approval to two additional criminal judgeships and one chancery judgeship--all to be in place on September 1.

Just who will be chosen to sit on the new courts will be determined by the standard application process with a judicial selection committee reducing the slate of candidates to three for each position. Gov. Phil Bredesen will appoint the new judges from the short list.

Application questionnaires are available and should be submitted through the Administrative Office of the Courts, Suite 600, Nashville City Center, 511 Union Street, Nashville, TN 37219. Each candidate must submit the original (unbound) and 18 copies, which must be stapled or bound and printed on front and back.

Applicants for one of the criminal court vacancies need not apply more than once to be considered for both positions.

Among those expressing an interest in a criminal court judgeship is General Sessions Judge John Brown, who said he was in the process of completing an application. No other sitting judges have announced their candidacy at this point.

The new judgeships will increase the number of criminal courts to six while adding a fourth chancery court.

Oddly enough, the additions come at an opportune time when all the state trial courts are operating in temporary quarters at the Metro Center

while the courthouse is undergoing major renovation and a new courts building is in the works. Even though leased space in the temporary location is currently at high occupancy, the quarters provide some degree of flexibility not previously available at the downtown venues.

To accommodate the two new criminal judgeships, Fifth Circuit Court Judge Walter Kurtz will surrender his courtroom at 601 Mainstream Drive and relocate to the Riverview Building where most of the other circuit courts are now located. Office space now being utilized by court administrative personnel will be converted to court use.

The courtroom being vacated by Kurtz will be shared by the two new criminal judges, much like the system adopted for Eighth Circuit Court Judge Carol Soloman when she was first elected and space was not available in the courthouse.

The new chancery judge will operate under the same format, rotating courtroom space with the three other chancellors in the First Image Building.

The temporary quarters are expected to be utilized for about three years with accommodations for all courts being incorporated in plans for the new permanent courts complex.

Joe Clinard Retires; Well, Just From Metro

Joe Clinard is probably best known for his late-in-life athletic prowess. But it was his departure from the workaday life with the Metro Legal Department that placed him centerstage last month.

Clinard, who began competitive marathon running at the age of 60 and went on to set several senior world records in indoor rowing, officially left public service behind him on May 30 when he told fellow workers and friends so long at a retirement reception in his honor.

It brought to a close 19 years of service to the legal department where he made his mark as Director of Insurance and Safety, serving four different mayors and seven legal directors. During that career, he successfully increased self-insurance funds from insignificant status to more than \$20 million.

Clinard was 65 years old and retired from the Shelby Mutual Insurance Company when he came to Metro in January 1984. By that time, he had already been married for 28 years to wife Mary, who now is mom to the couple's son Jody and daughter DeeDee. There are two grandchildren who take up much of Joe's and Mary's home time.

While in his 70's, Clinard set a world record in the 70-79 age group for the 5,000 meter distance. He went on to break his own record, not once but twice. His record still stands, as does his matching world record in the 80-89 age class. Also an avid pilot since 1939, he holds speed records for Ultralight flights between Centerville and Little Rock, Ark.

As for retirement? He will use the time trying out for the USA Indoor Rowing Team's upcoming competition in Europe. Go, Joe!


