Longtime General Sessions Court Administrator Warner Hassell has been elected to serve a three-year term on the Board of Directors of the National Association for Court Management.

His election came at the association's annual convention earlier this month.

The NACM is a nationwide organization dedicated to improvement of court management at all levels of court through the exchange of information and education.



Hassell has been a member of the association since becoming administrator of the General Sessions Court in September 1986.

As a member of the board, "I will be attempting to increase membership from Nashville and Tennessee in general while handling any inquiries you may want me to explore on a national basis," he said.

As General Sessions administrator, Hassell manages a metropolitan limited jurisdiction court that is the second largest in the state with a \$10 million budget, 11 fulltime judges, five

During his tenure as court administrator, he has been instrumental in the development and implementation of the automated records management systems for the court's Probation Department, the court administered DUI School and the court's newly implemented On-Line Traffic School. He was the court's representative on the planning committee for the new \$49 million Justice A. A. Birch facility.

He received a BS degree in political science from the University of Tennessee at Martin and worked as a budget analyst for the Tennessee State Senate while earning his Masters degree in public administration from Tennessee State University. Before assuming his current position, he served as director of the Tennessee Judicial Information System for the Tennessee Supreme Court-Executive Secretary's Office.

Hassell and his wife of 28 years, Marilyn, are the parents of two grown daughters, Meredith and Rebecca.
