New Law Guards Privacy of Domestic Litigants

A new law designed to block public access to vital personal information of litigants in domestic court cases goes into effect on July 1.

No longer will divorce complaints, petitions for legal separation, paternity orders and child support orders include social security numbers on original complaints.

Instead, that information, along with parties' full names, current mailing addresses and dates of birth, must be included in a separate document to be filed and kept under seal in the protective custody of the clerk.

The filing party will be required to file both documents simultaneously and include an 8.5x11 inch envelope labeled with the names of the parties.

The same rule will apply to orders derived from paternity and child support cases with separate documents listing names, social security numbers and dates of birth.

The law effectively addresses the issue of identity theft.

In conjunction with the new requirements, temporary injunctions will be required on all petitions for divorce and/or legal separations, along with additional injunctions incorporated in the new statute.

Burkett Retires From Night Court; Harris Gets Seat

Gerald Burkett, the first bilingual commissioner to serve on the General Sessions Night Court, has retired after eight years of service.

Judges have selected attorney Evan Harris to replace him on the five-member court, which presides over proceedings that take place after normal business hours. The transition will take place on July 2.

During his tenure on the court, which was preceded by 18 years of serving as a substitute commissioner, Burkett translated documents into Spanish for the court, Pretrial Services and the police department.

Harris, a 1997 graduate of the Nashville School of Law, is a member of the Harris Law Office, a family practice.

Mother, Daughter Serve On Same Jury

When a mother and her daughter who live on opposite sides of the county received summonses for jury duty at the same time, it was coincidence enough.

But when they both were selected to serve on the same jury? That was even more bizarre.

Yet, that's what happened when Sherri Hite, who lives in Antioch, found herself in the jury assembly room at the same time as her daughter Abby Hite, a resident of Hermitage, whose report date was the same.

Both were excited about sharing each other's company while waiting to see if they would be selected as possible jurors. "I liked that," said Abby, a deputy clerk in the Davidson County Register of Deeds Office. "I had me a lunch buddy."

Mom Sherri, a secretary for Metro Nashville Public Schools, had served once before, but it was Abby's first jury experience.

Imagine their surprise when both their names were called out for the juror qualifying phase of a civil case scheduled to get underway that day.

Each wondered if she would be accepted on the jury, but neither one dreamed the opposing attorneys would accept them both. What are the odds?

But that is exactly what happened. And, following two days of testimony before Circuit Judge Walter Kurtz, the mother and daughter agreed with the majority of their panel peers and found in favor of the plaintiff, awarding him a five-figure dollar amount for back injuries he suffered when he was knocked down by a neighbor's dog.

It is believed to be the first time in Davidson County that a mother and daughter have served on the same trial jury. As for Abby Hite, she would probably welcome the chance to do it again. "I liked the experience," she said. "The system worked really well."

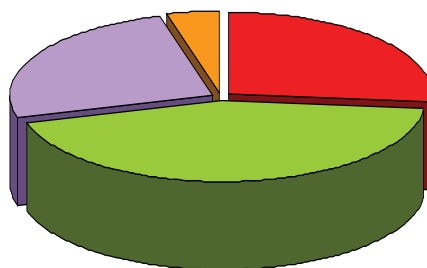
Tears...
