## New law applies to all 55 and older decedents, regardless of insurance enrollment

## TennCare Release Required in Estate Closings


Changes in the estate recovery law (see T.C.A. § 71-5-116) which took effect on January 1 now make it mandatory for all estates to obtain a release from the Bureau of TennCare before an estate can be closed in the Probate Court if the deceased person was age 55 or older at the time of death.

Prior to the change, a release from TennCare was only required if the deceased was age 55 or over and enrolled in TennCare at the time of death. Formerly, if the decedent was age 55 or older but not enrolled in TennCare at the time of death, the Probate Court would allow the personal representative to close the estate by simply filing a sworn statement verifying that the person was not enrolled in TennCare.

Now, however, the law makes it mandatory for all estates of those 55 or older to obtain a release regardless of whether the deceased was ever enrolled in TennCare. Thus, a written statement from the personal representative is no longer sufficient in those cases.

The change comes as the state continues to refine its efforts to recover reimbursement from estates for benefits paid through the Medicaid portion of TennCare for long term care assistance in nursing homes. Although not widely known, if TennCare pays the nursing home bill for someone, federal law requires that the state try to recover that money from the person's estate after they die

# Notice for Circuit and **Probate Appeal Filings**

In an effort to utilize our resources to their greatest potential since returning to the Historic Courthouse, Deanna Alexander, the deputy clerk who works on all appeals for the Circuit and Probate Court Clerks' Offices, is now located in the Probate Clerk's Office.

## Payments Top \$1 Million in First 5 Months

The convenience of paying traffic tickets online has drawn a responsive chord from the county's motoring public, many of whom are finding the new service an immediate remedy to outstanding penalties and threats to their driving privileges.

Since launching the online service in late January, the Traffic Violations Bureau has reported a sharp increase in the number of online payments, which topped the \$1 million dollar mark in June.

The popularity of the new service is evidenced by a 68 percent increase in the number of tickets paid online daily, rising from an average of 54 a day in February to 91 per day in a July interim audit. As of mid-July, credit card transactions accounted for about 15 percent of the bureau's total receipts.

Thirty-five percent of the payments were received from drivers whose fines were past due and had been turned over to the warrant office for collection.

Credit card conveyances are limited exclusively to the Circuit Court Clerk's web site and are not accepted as counter transactions.

unless a statutory exemption applies.

In addition, the estate recovery law now requires personal representatives to notify the Bureau of TennCare, within 60 days of the issuance of letters of administration or letters testamentary, of the death of any individual age 55 or older. The personal representative must then file an affidavit with the clerk confirming that notice has been given to TennCare.

Finally, although the mandatory requirement for a TennCare release only applies to estates wherein the deceased was age 55 or older, any estate may request a release from TennCare, and it may be advisable to do so if the deceased was under age 55 and owned any interest in real estate at the time of death.

To assist those handling estates, the state's form for requesting a release from TennCare can be obtained at our web site at www. nashville.gov/circuit/probate or can be obtained over the counter in the clerk's office.

"The online credit card service provides a perfect opportunity to those drivers who are financially challenged and find themselves in the position of losing their licenses or having their wages attached," said Circuit Court Clerk Richard Rooker, who has administrative authority over the Traffic Violations Bureau. "By providing this service to our customers, we are offering them an opportunity to satisfy their obligation to the

government and stretch out their payments over a period of time, which can be easier for them to manage."

"The most important thing," Rooker continued, "is that they eliminate the risk of losing their driving privileges and jeopardizing their ability to earn a living."


Moreover, the biggest advantage of the online service is the convenience of promptly keying the payment information into your computer and not forgetting to put it in the mail or having to go to court.



It's the modern way of doing business and is growing in acceptance within various governmental departments. Earlier this month, the General Sessions Court Traffic School expanded its online class enrollment program to include credit card fee payments and completing certain class courses--all in the pleasant surroundings of home or office.

Traffic School Director John Slate noted that only applicants who qualify for first offender and/or the four-hour defensive driving class are eligible to take the courses online. All others must attend classroom sessions.
