


SUPREME COURT RULE 31, SEC. 11 AMENDED

New Time Limit to File Complaints Against Rule 31 Mediators

Effective January 1, 2010, Section 11 of Rule 31 of the Supreme Court Rules, which governs proceedings for the discipline of Rule 31 Mediators, has been amended in pertinent part to state, "All complaints against an active Rule 31 Mediator must be post-marked no later than 180 days after the date of the last mediation session and must be submitted to the Programs Manager of the Administrative Office of the Courts." For all mediations in which the date of the final mediation session was prior to January 1, 2010, the 180 day limitation period will be calculated from January 1, 2010.
