



Chancellor McCoy Retires

After two decades on the bench, Davidson County Chancellor Carol McCoy has retired from her position. According to the [Tennessee Administrative Office of the Courts](#), McCoy presided over high-profile cases such as the Tennessee Voter Identification Act, the Open Records Act and the TennCare lawsuit. Prior to being elected to the bench in 1996, she worked at Legal Services (which later became the Legal Aid Society of Middle Tennessee and the Cumberland), the Tennessee Department of Revenue and as a partner at two law firms. McCoy was a founding member of the Lawyers Association for Women and CABLE, presiding judge of the 20th Judicial District from 1999-2001 and president of the Judicial Conference in 2009-2010. Bill Young has been appointed to serve in Chancellor McCoy's position.



Additions to the New Justice Center

The former Davidson County Criminal Justice Center is undergoing demolition work, and the county sheriff has announced that the new jail will include a mental health unit. The 64-bed section will be for those arrested on misdemeanor charges who do not pass a mental health evaluation, according to [NewsChannel5](#). The project's overall budget is \$113 million, with \$10 million going towards the mental health unit. The new facility is expected to open in 2019.

Legal Aid Receives Funding for Domestic Violence Work

Legal Aid Society of Middle Tennessee and the Cumberland

The Metropolitan Government of Nashville and Davidson County will give the Legal Aid Society of Middle Tennessee and the Cumberland a \$186,500 grant to be distributed in the current fiscal year. This money is allocated for survivors of domestic violence and will be used for legal representation, attendance at order of protection hearings and community education. Last year, the group was able to provide assistance to 279 victims, attend 136 court dockets and publish more than 1,150 self-help guides and other education materials through similar funding.
