



## Music City Community Court Serves Hundreds

The General Sessions Music City Community Court, Division 8, was founded in 2012 by Davidson County Judge Rachel L. Bell to focus on providing preventive and diversionary justice, held two Saturday dockets in October and November

The Community Service Docket is a “one stop shop” under advisement return docket where offenders are able to participate with the Tennessee Department of Transportation Adopt- A- Highway Program. And the Pro Se Indigency Docket and Expungement Clinic processed over 500 criminal records to be expunged along with several lawyers providing pro bono legal services in efforts to assist offenders filing out affidavits that are presented to the court for declaration of indigency.

## Alumna of the Year Honor Given to Former Prosecutor

Assistant attorney general for the District of Columbia Dr. Jamie Carter was named the 2016 Lee University Department of History, Humanities and Political Science Distinguished Alumna of the Year, per [The Cleveland Banner](#). Carter was instrumental in establishing the “good-faith exception” in Tennessee, which allows unconstitutionally obtained evidence to be presented in court if collected “in good faith” by law enforcement. Carter has also held positions as Knox County assistant district attorney and acting assistant district attorney in Davidson County.
