E-filing Official

E-filing is launched in the following courts:

- Circuit
- Probate
- General Sessions Civil –Limited to Orders of Protection and Emergency Commitments Only (Tentative full launch this fall)

The system is free to use and does not require any sign-up fees or document fees. There is a 2.25% convenience fee added to the standard filing fees if you pay by credit card or e-check. We have also set up escrow accounts that will allow Attorneys to e-file without incurring this charge. If you would like to set up an escrow account to use with your e-filing account, visit <http://circuitclerk.nashville.gov/home/escrow.asp> for more information. We have developed detailed user guides and video tutorials on our website to help facilitate this transition.
