DUE TO SUSPENSION OF IN-PERSON HEARINGS DUE TO COVID-19 PANDEMIC, THERE WERE NO NON-JURY OR JURY HEARINGS REPORTED DURING MAY IN CIRCUIT COURT

THE TENNESSEE SUPREME COURT ISSUED AN ORDER ON MAY 26, 2020, EXTENDING THE STATE OF EMERGENCY CAUSED BY COVID-19 BUT EASING THE SUSPENSION OF IN-PERSON HEARINGS. A COPY OF THE ORDER CAN BE VIEWED AT TNCOURT.GOV/CORONAVIRUS. THE SUSPENSION OF JURY TRIALS REMAINS IN EFFECT THROUGH FRIDAY, JULY 3, 2020. THE MORATORIUM ON ACTIONS TO EFFECTUATE EVICTIONS WAS LIFTED ON JUNE 1, 2020. HOWEVER, THE PERSON OR ENTITY SEEKING SUCH EVICTION MUST FILE A DECLARATION UNDER PENALTY OF PERJURY DECLARING THAT THE PROPERTY IS NOT SUBJECT TO THE RESTRICTIONS AND LIMITATIONS OF THE "CARES ACT." THIS DECLARATION MUST BE FILED NO LATER THAN TEN (10) DAYS PRIOR TO ANY HEARING ON THE MATTER.

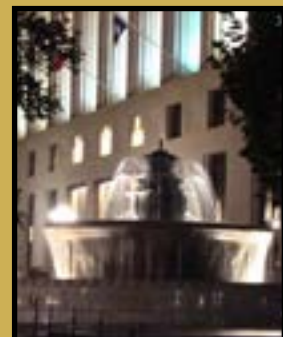
