DUE TO THE ONGOING LIMITATION OF IN-PERSON HEARINGS DUE TO COVID-19 PANDEMIC, THE ONLY REPORTED TRIAL RESULT IN CIRCUIT COURT FOR THE MONTH OF JUNE WAS A TELECONFERENCE ADMINISTRATIVE APPEAL HEARING IN THE 5TH CIRCUIT COURT IN 19C1653. RESPONDENTS HAVE UNTIL 7-31-20 TO SUBMIT SUPPLEMENTAL REPLY BRIEF.

THE PRESIDING JUDGE FOR GENERAL SESSIONS COURT ENTERED AN ORDER ON JULY 23, 2020, INSTRUCTING THAT NO LANDLORD / TENANT EVICTION CASES SHALL BE HEARD IN GENERAL SESSIONS COURT THROUGH AUGUST 29, 2020. THE ORDER EXPRESSLY REFERENCES THAT THIS MEASURE WAS TAKEN IN LIGHT OF THE FACT THAT DAVIDSON COUNTY HAS BEEN PLACED IN THE RED RANGE BY THE CENTERS FOR DISEASE CONTROL (CDC) AND IN RESPONSE TO NASHVILLE REVERTING BACK TO PHASE 2 OF THE COVID-19 RECOVERY PLAN.

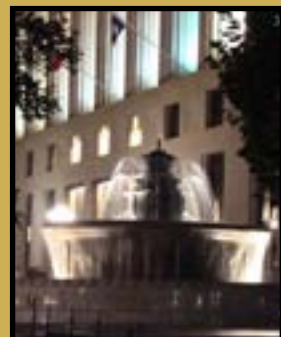
